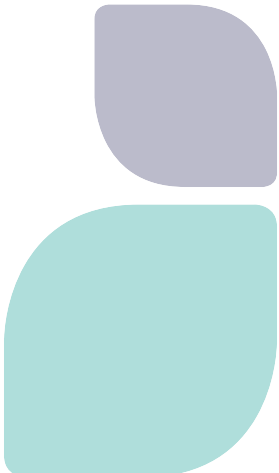

Tips and suggestions

- The North West Local Land Services (LLS) is committed to working with land managers to invest in the long term sustainability of our region. We encourage and invite innovative land managers to apply for funding that supports improved management of natural resources across the region. Funding is available for on-ground projects that achieve improved natural resource management and farm production.
- Talk to your neighbours! Projects that extend across property boundaries often deliver better outcomes.
- If there are three or more landholders either as neighbours or common geographic area please indicate in your form that you are part of a group.
- If your project is going to improve the habitat for an identified threatened species or vegetation community then please be sure to mention it.
- Applicants must make a minimum of a 50:50 contribution. The landholder contribution can include in-kind contribution.
- Typically project works are to be completed within a 12 to 18 month time frame. The North West LLS will work with you throughout implementation and offer additional support.
- Successful applicants will be required to enter into a Management Agreement with the North West LLS.

Please note that work you undertake before or after the timeframe for the project, or work that has already been completed at the time of application is not eligible for funding.

Who is eligible for funding?

- Individual landholders in the North West LLS region*
- Groups of landholders (this may include Landcare groups, producer groups, neighbouring landholders working together etc.) Please remember that if you are applying as part of a group of landholders that each landholder involved should fill out an application and indicate that they are part of the group.
- Local Government (however the available funding for Local Government is limited)
- Community groups wishing to improve natural resource management

These *on-ground grants* are supported through the National Landcare Programme and Catchment Action NSW

* The North West LLS region is defined as within the Gunnedah, Gwydir, Liverpool Plains, Moree Plains, Narrabri, Tamworth Regional and Walgett Shires.
